Overview of Traditional Prior Learning Credit Guidelines

- The residency policy requires all students to earn a minimum of 20 credits toward their degree at Bates Technical College
- Credits awarded at Bates may not be transferable to other institutions
- No partial credits shall be awarded
- Transfer credit from other colleges require an official transcript and a Request for Credit Evaluation form
